### New Highway-Pickup Czar, Anne Newcombe, Updates KUUF on Activities/Procedures

During the youth of KUUF, the state assigned us 3 miles of M-26. Fewer and fewer fellowship members participated in the past ten years.

Anne Newcombe has developed a plan that should turn this around. Her work on the first pickup this year appears to be successful, although with a few sections not yet covered.

Instead of assembling volunteers as a group and sending them out on a specific day, Newcombe asks volunteers to select part of the highway to cover all three pickup times over the warm months.

Newcombe reports that several; easy sections remain available. Section 12 begins at the "Adopt-A-Highway" sign just south of the bridge. It runs to Lakeshore Avenue.

Section 11 goes from Lakeshore Avenue to the Houghton Canal Road.

Section number 8 is perhaps the most accessible of all, running from Sharon Avenue (Econo intersection) to Jacker (AutoZone). This

flat, level, and wide sidewalk offers almost no off-sidewalk portions, allowing access to volunteers of more limited mobility.

While the main statewide dates for the first pickup days have passed, adoption groups can implement the "continuous monitor" method, just keeping an eye on their assigned sections as the volunteers travel back and forth, stopping on an "as needed" basis now through October.

If bags are collected at times separate from the statewide dates, Anne says she will pick them up, once she is notified:

## Remembering Stephen Fritchman: Unitarian Historical Figure and Thinker



Are you ready to be stimulated intellectually? If so, stop at our little library next Sunday and look at For the Sake of Clarity: Selected Sermons and Addresses, by Stephen H. Fritchman.

Fritchman was a leading figure in 20<sup>th</sup> Century American liberal

religion as well as a Unitarian minister.

The Fritchman Publication Committee has compiled over 45 of his most important sermons, addresses, and radio talks covering a wide range of topics. This group has now made these available to UU ministers, historians, and everyday readers like you.

Here are a few topics Fritchman covers:

- "How Do Unitarians Think of Jesus?" (given in the early 1940s)
- "How Do Unitarians Face Death?" (radio address—1/28/1951).
- "That Vastly Overrated Bestseller: The Bible" (2/17/1963).

Fritchman is worth reading. Take a look at this collection of his thoughts. We have one copy available.
